

Our History

At the close of the Civil War, soldiers and officers of the 62nd United States Colored Infantry, stationed at Fort McIntosh, Texas, but composed primarily of Missourians, took steps to establish an educational institution in Jefferson City, Missouri, which they named Lincoln Institute. The following stipulations were set for the school:

- 1. The institution shall be designed for the special benefit of the freed African-Americans;
- 2. It shall be located in the state of Missouri;
- 3. Its fundamental idea shall be to combine study and labor.
 - Members of the 62nd Colored Infantry contributed \$5,000; this was supplemented by approximately \$1,400, given by the 65th Colored Infantry. On January 14, 1866, Lincoln Institute was formally established under an organization committee. By June of the same year, it incorporated and the committee became a Board of Trustees. Richard Baxter Foster, a former first lieutenant in the 62nd Infantry, was named first principal of Lincoln Institute. On September 17, 1866, the school opened its doors to the first class in an old frame building in Jefferson City.
 - In 1870, the school began to receive aid from the state of Missouri for teacher training. In 1871, Lincoln Institute moved to the present campus. College-level work was added to the curriculum in 1877, and passage of the Normal School Law permitted Lincoln graduates to teach for life in Missouri without further examination. Lincoln Institute formally became a state institution in 1879 with the deeding of the property to the state. Under the second Morrill Act of 1890, Lincoln became a land grant institution, and the following year industrial and agricultural courses were added to the curriculum.
 - In 1921, the Missouri Legislature passed a bill introduced by Walthall M. Moore, the first black American to serve in that body, which changed the name from Lincoln Institute to Lincoln University and created a Board of Curators to govern the University. The North Central Association of Colleges and Secondary Schools accredited the high school division in 1925, the teacher-training program in 1926, and the four-year college of arts and sciences in 1934. Graduate instruction was begun in the summer session of 1940, with majors in education and history and minors in English, history, and sociology. A School of Journalism was established in February 1942. In 1954, the United States Supreme Court handed down its ruling in *Brown v. Board of Education*, and Lincoln University responded by opening its doors to all applicably meeting its entrance criteria. Today, Lincoln University serves a diverse clientele, both residential and non-residential, engages in a variety of research projects, and offers numerous public service programs in addition to providing an array of academic programs.



II. The luncheon proceeds are to pay for the following:

Lunch; Speaker love offering - out of town speaker (the chapter pays for airline ticket, hotel and rental car. In town speaker - love offering. Awards for alums who retired in the previous year. Ex. April 2015 - Feb. 2016; Entertainment; Giveaways - give guest a ticket and pull names for the gifts. Alumni pins - the chapter celebrates reunion year (contact alumni affairs for pin \$10.00 each); Willowtree Angel - Remembrance for alums who have passed in the last year. (Invite alums family and present angel)

If the ticket price doesn't cover all the above expenses the chapter covers the needed funds.

III. Student Scholarship Donations

Alums are asked to donate to student scholarships. The start amount is the year the university is celebrating (e.g. 150th anniversary). The amount would be \$150.00 honoring the soldiers' memory. In January 2004, the Metro-Atlanta Alumni Chapter of Florida A&M University hosted a Mixer as a fundraiser and invited other Historical Black Colleges and Universities (HBCU) alumni chapters to join in on the fun and the opportunity to recruit new members. While only a handful of Chapters were active participants, this was enough to spark a fire that led to the creation of the Atlanta HBCU Alumni Alliance (AHBCUAA). The mission of the Atlanta HBCU Alumni Alliance is to serve as an advocate for HBCU Alumni Associations by supporting the mission of HBCUs through scholarship fundraising, alumni reclamation and student recruitment in addition to aligning with the National HBCU Alumni Alliances by supporting and participating in programs that promote higher education, encourage healthy living, and fighting hunger.

In 2005, the Lincoln University (MO) Atlanta Alumni Chapter, Inc. became a member of the (Atlanta HBCU Alumni Alliance) AHBCUAA. Our role in this organization is to promote the sustainability, growth, and continuous achievement of HBCU's. We do this by first recognizing our commitment to Lincoln, and second, we serve as an instrument for other alums to follow. We further recognize our need to set an example for those who will continue to identify different ways to serve our HBCU's interest.

Moreover, each year, our chapter members participate in the HBCU Mixer and the 5K/10K Run/Walk fundraising initiatives presented by the AHBCUAA. During these events, each chapter is encouraged to sell tickets to attend the Mixer, and register as many fellow alums as possible to participate in the 5K/10K Run/Walk fundraiser. The benefit to the LU Chapter is the financial outcome which is within the distribution of the disaggregated sum of all the funds raised by all chapters participating. In 2016, the chapter received \$257.46 in revenue. However, in years past, the chapter has earned as much as \$1,200.00, so please considered supporting these AHBCUAA fund raising initiatives.

In summary, our financial benefit as a chapter is based on our local member's participation in both the Mixer and the 5K/10K Run/Walk fundraisers. In accordance with the Lincoln University (MO) Atlanta Alumni Chapter, Inc. Constitution and Bylaws, the President, Mr. Jerrold Brantley appointed Mr. Edwin Hamilton, and Dr. Theresa Smotherman to serve as nomination and election chair's respectively for purpose of nominating and electing eligible candidates to fill and serve in the following positions: Chapter President, Chapter Secretary, and Chapter Parliamentarian/Chaplain.

Upon receiving this appointment, the committee chairs collaborated and successfully, implemented the 2016 elections. Through secret mail-in ballots the committee chairs achieved the following results: (1) Chapter President Elect – Dr. Sherman Bonds, (2) Chapter Secretary - Mr. Antonio Lewis, and (3) Chapter Parliamentarian/Chaplin - Rev. The nomination process had both an opening period and closing period for all offices being solicited for nominations. Moreover, the following principles were applied for the nomination process:

- > Alumni chapter members who nominate candidates for office must be financial with the Lincoln University (MO) Atlanta Alumni Chapter at the time they submit nominations.
- Nominated candidates must be financial with both the Lincoln University (MO) Atlanta Alumni Chapter and the Lincoln University (MO) National Alumni Association before accepting nominations.
- > The Nominations Committee Chair determined the nomination period, allowing time for the Elections Committee Chair to conduct the election.
- > The Nominations Committee Chair turned the names of the nominees over to the Elections Committee Chair at the end of the nomination process.

Upon receiving the nominating committee chair's slate of candidates nominated to be elected for the offices solicited, the Election Chair executed the following procedures:

- The Elections Committee Chair worked with the Chapter Treasurer to determine the eligibility of the nominated candidates, based on the nominees' financial status with both the Lincoln University (MO) Atlanta Alumni Chapter and the Lincoln University (MO) National Alumni Association.
- > The Elections Committee Chair secured the agreement from each nominee to run for the office for which he/she had been nominated.
- > The Elections Committee Chair determined:
 - 1. Date for announcement of candidates;


- 2. Campaign period;
- 3. Ballots distribution process and date;
- 4. Ballot return deadline and/or election date; and
- 5. Date of the announcement of winners.
- The Election Chair made the decision that the election procedures would be completed through the mail-in ballot process. Therefore, the write-in candidate practice was implemented to allow other names to be submitted for office, as it would be permitted from the floor if elections were held in an open forum.
- All chapter members voting in the election paid their current year dues at least 30 days before the election. Dues paid during this period are good only until December 31 of the election year and will not be prorated regardless of when they were paid.
- Each candidate was notified through electronic email informing them of the election process, including: (a) period for opening and concluding their respective campaign announcements; and (b) a list providing contact information concerning eligible voters.
- Financial Chapter members were informed of the election period, and ballots were issued with instruction for returning their vote. A stamped returned envelope was included in the mailed ballot enveloped.
- > At the end of the election period, the Election Chair, Nominating Chair and two additional chapter members counted the ballots that were returned on the second day after the deadline for returning all election ballots had expired.
- > After counting the election ballots returned, and identifying the elected officers for the chapter, the 2016 election results were disclosed to the chapter through electronic communication, and the 2016 election of officers was concluded.
- The date for installation of the newly elected officers was determined by the President of the Lincoln University (MO) Atlanta Alumni Chapter presiding during the election process.

LU Homecomíng Fundraíser 2016 Mrs. Patricia Neal-Stinson, Chair

During our August chapter meeting, it was suggested that we could do a fundraiser during homecoming to show our support for the university's 150th Sesquicentennial Anniversary. The idea was based on the fact, the university bookstore was closed, and the chapter could sell 150th souvenir memorabilia during homecoming, and support our students during the process. As chair of this ad hoc committee, I sought the leadership support of the chapter President, Mr. Jerrold Brantley, Dr. Zelma Frank, Mrs. Lettie Carter, Ms. Denise Bland, Mr. Lovell Lemons, and Dr. Sherman Bonds, which served as our fundraising committee for this sales event.

Furthermore, where the Chapter holds an account within the University Foundation under the title of Atlanta Chapter Special Purpose Fund, we had available for use \$6,593.00. As prescribed by its purpose, (which is designated for chapter fundraising) we accessed \$3,331.20 for this initiative. The committee approved the selection of the products that were sold, and Dr. Bonds crunched the financial numbers to ensure our success. The event was a success, and we generated a profit of \$417.80. All funds were returned including the profit, to our Atlanta Chapter Special Purpose Fund account. A detailed accounting of this event/activity is cited within the treasurer's financial report.

The students and Dr. Bonds did a tremendous job in working the event sales project during homecoming. All students participated at some point during the homecoming celebration. 



Treasurers Report 2016 Mrs. Patricia Neal-Stinson, Chair

Greeting fellow alums, the Lincoln University (MO) Atlanta Alumni Chapter, Inc. has been very active and supportive, and we thank you for all that you have done in the past and what you plan to do in the future. The following narrative is a summary of the financial activity that our chapter was engaged in throughout the 2016 calendar year.

First, you should know, the chapter generated, received and processed \$38,871.45 through our local chapter bank account for the calendar year ending December 31, 2016. The chapter's bank account balance reflects a total of \$3,937.03, which is being carried forward for the 2017 calendar year. Categories where the carryover funds are applied can be viewed under the heading Lincoln University (MO), Atlanta Alumni Chapter, Inc. Bank Account Balance.

Next, as you review this financial report you should notice the details for all income, expenses and expenditures generated and applied for the 2016 calendar year. This report reflects: Current Membership analysis for dues paid; Chapter Financial Report; Chapter Estimated Budget 2016, with an analysis for reconciliation of chapter expenses verses estimated budget and actual expenditures; and the Founder's Day Revenue report.

Furthermore, you may review the following reports as they are described herein: HBCU Fundraiser; Founder's Day Fundraiser 2016; Founder's Day Fundraiser 150th: Report; Family and Friends Scholarship Fundraiser (which may be better known as the student send-off); and our Golf Tournament Weekend Fundraiser. This financial report concludes with a presentation of the Lincoln University (MO), Atlanta Alumni Chapter, Inc. Bank Account Balance report, a statement of funds that were raised to support the LU Foundation Car Raffle, revenue generated as a result of our LU Homecoming Event Sale, and a financial statement of the Lincoln University Foundation Atlanta Chapter Accounts.

Finally, as you complete your review of this financial report you should see and examine the President Elect's Estimated Chapter Budget for 2017 following this financial report. Where some may have not noticed,

we have always held an estimated budget for chapter expenditures. However, we have not always had those many active financial supporters to fully fund our estimated budgets, so we did the best we could with whatever support was brought forward by those who paid their annual dues.
